In accordance with 17 and 26 of the *Planning Act, R.S.O., 1990, c.P. 13*, as amended, the Municipality of Callander invites you to attend an Open House to discuss the proposed Official Plan.

The Official Plan is a statement of goals, objectives and policies to guide future growth within the Municipality for a 20-30 year horizon.

The current Official Plan has been in-effect since 2011. The purpose of this Official Plan Update project is to review the document to make sure it is up to date with local and provincial goals and objectives including the Planning Act, Growth Plan for Northern Ontario and Provincial Planning Statement.

If you wish to be notified of the decision of the Municipality of Callander on the proposed Official Plan, you must make a written request to the Municipality of Callander at the contact listed.

NOTE:

If a person or public body would otherwise have an ability to appeal the decision of the Municipality of Callander to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Callander before the proposed official plan is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Callander before the proposed official plan is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
